In exchange for the Underwriter support provided by the above named non-profit organization to Lake Region TV (LRTV), a non-profit 501(c)(3) organization staffed entirely by volunteers to provide Community Access Television to Bridgton, Harrison, and Naples, LRTV agrees to provide the following acknowledgement of such support:

Message Board (\$30 per month, first month prepaid)

- 1) LRTV shall prepare and cablecast on the Adelphia cable television system channels 4 and 12 up to three (3) screens of information having a maximum of 30 seconds of total display time and repeating approximately 3 to 4 times each hour during the period when live or videotaped programming is not being cablecast by LRTV - approximately 19 hours per day from 10 p.m. to 5 p.m.

Screens may not include any price or detailed product specific advertising.

Minor modifications to screens may be made at the request of the Non-Profit Underwriter no more than once monthly. Minor modifications made more frequently than monthly will incur a special setup or modification fee of \$ 5. Major modifications of one or more screens will incur a special setup or modification fee of \$25. Requests for modifications must be made in writing at least seven (7) days prior to the date the modification is to become effective.

Up to two (2) additional screens of information (maximum of five (5) screens total) may be utilized by paying an additional Non-Profit Underwriter fee of \$ 10.00 per screen per month.

Up to four (4) digitized images, logos, or items of clip art (including animated gif's) may be included as either background for or as inserts on each screen permitted above and may be provided either as hard copy, on 3 1/2" IBM compatible diskette, 100MB Zip diskette, or transmitted via e-mail.

No Non-Profit Underwriter will be offered or receive an "exclusive" opportunity to become a LRTV underwriter based upon their type of non-profit organization.

LRTV shall not be responsible for its inability to cablecast either the Community Message Board screens due to unexpected failure of equipment, power outages, or to errors made by our volunteers in scheduling of live or taped programming.

- 3) The Non-Profit Underwriter may terminate this agreement provided that the request for termination is provided to LRTV in writing at least five (5) days prior to the beginning of the month.
